01 | Pennsylvania's Education Tax Credit Programs



Pennsylvania's education tax credit programs are one of the only ways you can decide where a portion of your state taxes go. Instead of sending those dollars to the state, you can choose to invest them directly in students and families.

Impact of Education Tax Credit Programs on Financial Aid at Eden

SCALE OF IMPACT

- **Over \$4M** awarded in need-based tuition assistance in the past five years

ESSENTIAL SUPPORT

- **Almost 90%** of Eden's tuition assistance comes directly from PA tax credit programs

LIVES CHANGED

- **Nearly half** of students receiving aid are supported directly through tax credit funding

PA education tax credit participation is one of the most meaningful ways to expand access to Eden Christian Academy. By turning taxes you already owe into life-changing tuition assistance, you help make an Eden education possible for more families.



Understanding Pennsylvania's Education Tax Credit Programs

Pennsylvania offers two primary education tax credit programs—though very similar, they are designed to expand access to tuition assistance in different ways.

- Educational Improvement Tax Credit Program (EITC)

- Redirected tax dollars support students in **pre-K — Grade 12**
- Supports need-based tuition assistance

- Opportunity Scholarship Tax Credit Program (OSTC)

- Redirected tax dollars support students in **K — Grade 12**
- Supports need-based tuition assistance, but is **reserved for students in the attendance areas of Pennsylvania's lowest-performing public schools** who choose another eligible school, such as Eden Christian Academy

02 | Education Tax Credit Programs and Eden

General Overview

- Managed by the PA Department of Community & Economic Development (DCED)
- Provide significant PA tax credits for eligible individuals and businesses—with potential federal benefits
- Redirect PA tax dollars to support financial aid for students, rather than to the state



How Tax Credit Giving Works at Eden



- Eden cannot receive tax credit donations directly from donors
- Contributions are typically made through trusted Scholarship Organizations (SOs)
- SOs handle the application and guide you through the process
- Businesses may also apply directly to DCED for tax credits, then complete their contribution through an approved SO

Who Can Participate?

- Essentially all businesses and individuals with Pennsylvania state tax liability are eligible to participate
- If you pay PA taxes, there's a strong chance you qualify
- It's simpler—and more accessible—than many expect



Financial Benefits & Lasting Impact



- Receive a 90% PA state tax credit
- May benefit from a federal charitable deduction on the remaining amount (if you itemize)
- Help make Christian education accessible for families who may not otherwise be able to afford it

03 | How to Get Involved

How to Get Involved Through a Trusted Scholarship Organization (SO)



- Individuals and many businesses choose this simple route through one of Eden's trusted Scholarship Organization (SO) partners.
- Some businesses may also choose to apply directly through DCED.



1. COMPLETE A SIMPLE FORM (Special Purpose Entity Joinder Agreement):

Complete a simple, one-page application (“joinder”) through an SO of your choice. Eden is happy to guide you through this process.

2. MAKE YOUR CONTRIBUTION

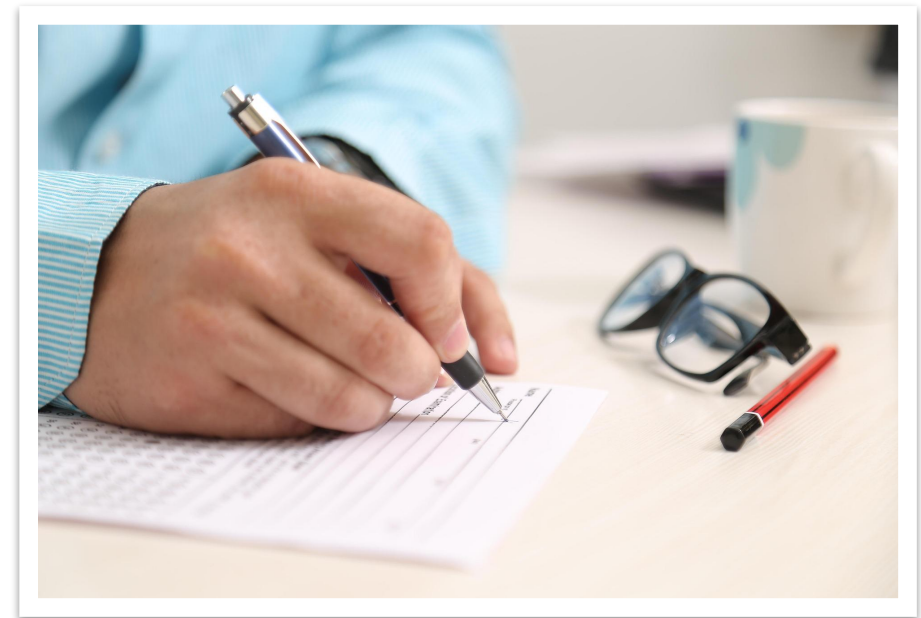
The SO will notify you once your joinder has been approved and will provide instructions for making your contribution. After your gift is received, funds are distributed to support need-based tuition assistance at Eden. Timing can vary—some applications are approved quickly, while others may take several months depending on when you apply.





3. RECEIVE TAX CREDIT FORMS (Typically Early Spring):

Once approved, your SO partner handles the SPE process, secures your tax credits through the DCED, and provides the forms or documentation needed to claim your credits. Timing may vary based on participation method and tax situation.

4. FILE YOUR TAXES:

When filing your PA tax return, you can apply your credit to reduce your state tax liability. If you've already paid taxes, you may receive a refund. If not, your credit will reduce what you owe. Unused credits may generally be carried forward to future tax years. For the smoothest experience, we encourage donors to consult their tax advisor and file promptly, as processing timelines can vary.





5. RECEIVE YOUR TAX BENEFIT (Typically Mid-Summer to Fall):

Many donors who itemize deductions may also receive a federal tax benefit. For example, a \$10,000 contribution may generate a 90% PA tax credit (\$9,000). The remaining \$1,000 may be deductible as a charitable contribution. Federal tax benefits vary based on individual circumstances—please consult your tax advisor.
